Australand Property Limited ("APL") as trustee of Australand Property Trust ("APT") had declared a trust in favour of FCL Investments (Industrial) Pte. Ltd. ("FCLI") pursuant to a declaration of trust dated 21 June 2016 (the "Declaration of Trust"). Pursuant to the Declaration of Trust, APL, as trustee of APT, holds the Trust Property upon trust absolutely for FCLI. The "Trust Property" includes 292,155,000 units in FLT held by APL, as trustee of APT (the "Sponsor Units"). Accordingly, FCLI is deemed interested in the Sponsor Units.

FCLI holds an aggregate of 6,209,846 units in FLT which were issued as payment of management fees payable to (i) FLIAM, the manager of FLT, and (ii) FLT Australia Management Pty Ltd ("FLTAM"), the investment manager of FLT Australia Trust ("HAUT") in respect of FLT and HAUT respectively, and which FLIAM and FLTAM had nominated FCLI to receive.

Frasers Centrepoint Limited ("FCL") is the immediate holding company of FCLI.

ThaiBev holds a 100% direct interest in International Beverage Holdings Limited, which in turn holds a 100% direct interest in InterBev Investment Limited. InterBev Investment Limited holds more than 20 per cent. of the issued share capital of FCL.

Accordingly, ThaiBev has a deemed interest in the 298,364,846 units of FLT ("Units") under section 4 of the Securities and Futures Act.
