units in FLT (fractions of a New Unit to be disregarded) to be held as at the books closure date at 5.00 p.m. on Friday, 18 May 2018.

The percentage of unitholdings "immediately before the transaction" is based on 1,854,733,376 Units in issue as at 7 June 2018.

The percentage of unitholdings "immediately after the transaction" is based on 2,006,886,813 Units in issue as at 8 June 2018.
