Frasers Property Industrial Trust Holdings Pte. Ltd. ("FPITH") holds an aggregate of 425,647,832 Units (the "FPITH Units") and FLIAM holds an aggregate of 5,956,113 Units (the "FLIAM Units").

Frasers Property Limited ("FPL") is the immediate holding company of FPITH and FLIAM. Accordingly, FPL has a deemed interest in the aggregate of 431,603,945 Units, which comprise the FPITH Units and the FLIAM Units, under section 4 of the Securities and Futures Act, Chapter 289 of Singapore ("SFA").

Siriwana holds more than 20% of the issued share capital of Thai Beverage Public Company Limited ("ThaiBev"). ThaiBev holds a 100% direct interest in International Beverage Holdings Limited, which in turn holds a 100% direct interest in InterBev Investment Limited ("IBIL"). IBIL holds more than 20% of the issued share capital of FPL.

Accordingly, Siriwana has a deemed interest in the aggregate of 431,603,945 Units, which comprise the FPITH Units and the FLIAM Units, under section 4 of the SFA.
