### **NOTICE TO UNITHOLDERS ON EXCHANGE RATE FOR COMPUTATION OF ADVANCED DISTRIBUTION IN AUSTRALIAN DOLLARS**

As announced on 23 October 2019 by Frasers Logistics & Industrial Asset Management Pte. Ltd., as manager of Frasers Logistics & Industrial Trust (“**FLT**”), the declared advanced distribution of 2.45 Singapore cents per unit in FLT for the period from 1 April 2019 to 7 August 2019<sup>1</sup> in connection with the private placement of 222,000,000 new units in FLT (“**New Units**”) at an issue price of S\$1.173 per New Unit (the “**Private Placement**”), will be paid on **Friday, 1 November 2019**.

For unitholders of FLT (“**Unitholders**”) who have opted to receive their distribution in Australian dollars, the amount of Australian dollar distribution to be paid will be computed based on the exchange rate of S\$1.00 : A\$1.0693, this being the buy rate for Australian dollars on 23 October 2019. Unitholders who have not opted to receive their distribution in Australian dollars will receive their distribution in Singapore dollars.
