16,071,957 new Units have been issued on 12 May 2020 comprising (a) 4,627,371 new Units for the payment of management fees ("Management Fee Units") to (i) FLCAM, as manager of FLCT (the "REIT Manager"), in respect of FLCT and (ii) FLT Australia Management Pty Ltd, a wholly-owned subsidiary of FLCAM, as investment manager of FLT Australia Trust (the "HAUT", and the investment manager of the HAUT, the "HAUT Manager"), in respect of the HAUT, and (b) 11,444,586 new Units for the payment of acquisition fees ("Acquisition Fee Units") to the REIT Manager, in respect of FLCT.

The REIT Manager and the HAUT Manager have nominated Frasers Property Industrial Trust Holdings Pte. Ltd. ("FPITH") to receive the Management Fee Units and have received cash in consideration for such nomination.

Prior to the issuance of 16,071,957 new Units on 12 May 2020, FPITH and FLCAM collectively held an aggregate of 738,360,241 Units. Following the receipt of the Management Fee Units and Acquisition Fee Units, FPITH and FLCAM collectively hold an aggregate of 754,432,198 Units.

Frasers Property Limited ("FPL") is the immediate holding company of FPITH and FLCAM. Accordingly, FPL has a deemed interest in an aggregate of 754,432,198 Units, under section 4 of the Securities and Futures Act, Chapter 289 of Singapore ("SFA").

IBIL holds more than 20% of the issued share capital of FPL. Accordingly, IBIL has a deemed interest in an aggregate of 754,432,198 Units, under section 4 of the SFA.
