## ANNUAL GENERAL MEETING OF FRASERS LOGISTICS & COMMERCIAL TRUST TO BE HELD ON 20 JANUARY 2021

- 1. **Background**: Frasers Logistics & Commercial Asset Management Pte. Ltd., as manager (the "**REIT Manager**") of Frasers Logistics & Commercial Trust ("**FLCT**") refers to the COVID-19 (Temporary Measures) Act 2020 passed by Parliament on 7 April 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed entities in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means and the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "**Order**") which was gazetted on 13 April 2020, and which sets out the alternative arrangements in respect of, *inter alia*, general meetings of real estate investment trusts.
- 2. **Date, time and conduct of Annual General Meeting**: The REIT Manager wishes to announce that pursuant to the Order, the 4<sup>th</sup> Annual General Meeting of FLCT (the "**AGM**") will be convened and held by way of electronic means, on **Wednesday, 20 January 2021 at 2.00 p.m. (Singapore Time)**.
- 3. **Issuance of Annual Report**: The REIT Manager has today issued the annual report of FLCT for the financial year ended 30 September 2020 (the "**Annual Report**") which contains, *inter alia*, the Notice of AGM and the proxy form (the "**Proxy Form**") for the appointment of the Chairman of the AGM as the representative of the unitholders of FLCT (the "**Unitholders**") at the AGM.

- 4. **No personal attendance at the AGM**: Due to the current COVID-19 restriction orders in Singapore, **Unitholders will not be able to attend the AGM in person**.
- 5. Alternative arrangements for the participation at the AGM:

Unitholders may participate in the AGM electronically via the following arrangements:

(a) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream:

Unitholders will be able to observe and/or listen to the AGM proceedings through a live audio-visual webcast or live audio-only stream via their mobile phones, tablets or computers. In order to do so, Unitholders must follow these steps:

- Unitholders must pre-register at FLCT's pre-registration website at the URL <a href="https://www.frasersproperty.com/reits/flct">https://www.frasersproperty.com/reits/flct</a> which is available from now until 2.00 p.m. on Sunday, 17 January 2021 to enable the REIT Manager to verify their status as Unitholders. Following the verification, authenticated Unitholders will each receive an email, which will contain a user ID and password details as well as instructions on how to access the live audio-visual webcast and to access the live audio-only stream of the AGM proceedings (the "Confirmation Email"), by 2.00 p.m. on Tuesday, 19 January 2021.
- Unitholders who do not receive the Confirmation Email by 2.00 p.m. on Tuesday, 19 January 2021 but have registered by 2.00 p.m. on Sunday, 17 January 2021 should contact the Unit Registrar, Boardroom Corporate & Advisory Services Pte. ### (b) submitting questions in advance of the AGM:

Unitholders will not be able to ask questions "live" at the AGM during the audio-visual webcast or audio-only stream. Therefore, it is important for Unitholders who wish to ask questions to submit their questions related to the resolutions to be tabled for approval at the AGM, in advance of the AGM, in the following manner:

- All questions must be submitted by 2.00 p.m. on Sunday, 17 January 2021:

- Addressing questions: The REIT Manager will address all substantial and relevant questions received at least 72 hours before the AGM prior to or during the AGM. The REIT Manager will publish the responses to the substantial and relevant questions which the REIT Manager is unable to address during the AGM, on FLCT's website and on SGXNET prior to the AGM. The REIT Manager will publish the minutes of the AGM on FLCT's website and on SGXNET, and the minutes will include the responses to the substantial and relevant questions which are addressed during the AGM.

# (c) Appointment of the Chairman as proxy to attend, speak and vote on their behalf at the AGM:

 Unitholders (whether individual or corporate) must appoint the Chairman of the AGM as their proxy to attend, speak and vote on their behalf at the AGM if they wish to exercise their voting rights at the AGM. In addition to the printed copies of the Proxy Form which will be sent to Unitholders, the Proxy Form may be accessed at FLCT's website at <a href="https://www.frasersproperty.com/reits/flct">https://www.frasersproperty.com/reits/flct</a>, and will also be made available on the website of SGX-ST at <a href="https://www.sqx.com/securities/company-announcements">https://www.sqx.com/securities/company-announcements</a>.

Where Unitholders (whether individual or corporate) appoint the Chairman of the AGM as their proxy, they must give specific instructions as to voting, or abstentions from voting, in respect of a resolution in the Proxy Form, failing which the appointment of the Chairman of the AGM as proxy for that resolution will be treated as invalid.

in either case, by no later than **2.00 p.m. on Sunday, 17 January 2021**, being 72 hours before the time fixed for the AGM.

A Unitholder who wishes to submit a Proxy Form must first complete and sign the Proxy Form, before submitting it by post to the address provided above, or before scanning and sending it by email to the email address provided above.

In view of the current COVID-19 restriction orders in Singapore and the related safe distancing measures which may make it difficult for Unitholders to submit completed Proxy Forms by post, Unitholders are strongly encouraged to submit completed Proxy Forms electronically via email.

• Unitholdings through intermediaries: Persons who hold Units through relevant intermediaries and who wish to participate in the AGM by (a) observing and/or listening to the AGM proceedings through live audio-visual webcast or live audio-only stream; (b) submitting questions in advance of the AGM; and/or (c) appointing the Chairman of the AGM as proxy to attend, speak and vote on their behalf at the AGM, should contact the relevant intermediary through which they hold such Units as soon as possible in order to make the necessary arrangements for them to participate in the AGM.

For the avoidance of doubt, CPF and SRS Investors who wish to participate in the AGM by (a) observing and/or listening to the AGM proceedings through live audio-visual webcast or live audio-only stream and/or(b) submitting questions in advance of the AGM should refer to paragraphs 5(a) and 5(b) above respectively. However, CPF and SRS investors who wish to appoint the Chairman of the AGM as proxy should approach their respective CPF Agent Banks or SRS Operators to submit their votes by **5.00 p.m. on Friday, 8 January 2021**, being seven (7) working days before the date of the AGM.
