6,209,181 new Units have been issued on 9 February 2023 for the payment of management fees (the new Units, "Management Fee Units") to (a) FLCAM, as manager of FLCT (the "REIT Manager"), in respect of FLCT and (b) FLT Australia Management Pty Ltd, a wholly-owned subsidiary of FLCAM, as investment manager of FLT Australia Trust (the "HAUT", and the investment manager of the HAUT, the "HAUT Manager"), in respect of the HAUT.

The REIT Manager and the HAUT Manager have nominated Frasers Property Industrial Trust Holdings Pte. Ltd. ("FPITH") to receive the Management Fee Units and have received cash in consideration for such nomination.

Prior to the issuance of 6,209,181 new Units on 9 February 2023, FPITH held an aggregate of 794,480,846 Units. Following the receipt of the Management Fee Units, FPITH has a direct interest in 800,690,027 Units (the "FPITH Units"). FLCAM holds 19,731,743 Units (the "FLCAM Units").

Frasers Property Limited ("FPL") is the immediate holding company of FPITH and FLCAM. Accordingly, FPL has a deemed interest in an aggregate of 820,421,770 Units, which comprise the FPITH Units and the FLCAM Units, under section 4 of the Securities and Futures Act, Chapter 289 of Singapore ("SFA").

ThaiBev holds a 100% direct interest in International Beverage Holdings Limited, which in turn holds a 100% direct interest in InterBev Investment Limited ("IBIL"). IBIL holds more than 20% of the issued share capital of FPL.

Accordingly, ThaiBev has a deemed interest in the aggregate of 820,421,770 Units, which comprise the FPITH Units and the FLCAM Units, under section 4 of the SFA.
