FURTHER UPDATE TO ANNOUNCEMENT ON CESSATION AS CHIEF EXECUTIVE OFFICER

Frasers Logistics & Commercial Asset Management Pte. Ltd., as the manager of Frasers Logistics & Commercial Trust (“**FLCT**”, and as the manager of FLCT, the “**Manager**”) makes reference to the announcements dated 14 February 2023 and 9 May 2023 on the cessation of appointment of Mr Robert Stuart Claude Wallace as the Chief Executive Officer of the Manager (the “**Cessation of Appointment**”) and the announcement dated 1 June 2023 on the appointment of the Chief Executive Officer – Designate of the Manager. The Manager wishes to update that Mr Wallace and the Manager have mutually agreed to further extend the effective date of the Cessation of Appointment from 1 August 2023 to 14 August 2023.

The Manager has identified Mr Wallace’s successor and the appointment is subject to regulatory approval as required under the Securities and Futures Act 2001 of Singapore. Mr Wallace has agreed to continue as Chief Executive Officer until the appointment of the incoming Chief Executive Officer for a smooth transition.
